MOTION FOR PRELIMINARY AND PERMANENT INJUNCTION

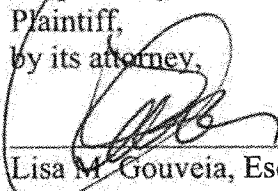
